Ms. Mayer was provided the opportunity to make public comment. Ms. Mayer explained that in her opinion the ADAB is not culturally diverse and does not represent community members with lived experience. It's people of color that have been killed, that go to jail, instead of getting the help they need. We need their voices. • Board members considered and discussed the comments made by Ms. Mayer. • Chair Avey indicated that language that supports cultural diversity should be included in the recommendations. • Chair Avey conducted a second vote with all members in favor of submitting the recommendations to the Mental Health Board that includes language that supports cultural diversity.
