[Mental Health Program Coordinator \[Licensed\] \(click to apply\)](#) to join our Assisted Outpatient Treatment (AOT) team. This position will provide supervision of the licensed counselors, interns, and paraprofessional staff, review referrals to ensure they meet criteria, create trainings, conduct outreach, create and maintain good relationships with community members and agencies, gather and analyze data for program evaluation and improvement (in partnership with the program planner), provide supervision and support to the team, respond to community inquiries, train staff, and manage the workload of the team. This critical position will provide strength based support, mentorship, program evaluation, provide outreach and training to the community, and lead and train staff on the team. This position provides critical to the team and in partnership with Division Manager, recommendations for program improvement and community engagement to support the work of the AOT program objectives to connect those who need AOT are connected and supported in the least restrictive community supports and services.

[Senior Behavioral Health Peer Specialist \(click to apply\)](#) to join our Assisted Outpatient Treatment (AOT) team. This position will provide intensive engagement to persons who are struggling in their mental health and are hesitant to connect to services. This critical positions will provide strength based support, crisis intervention services, linkages to services, provide outreach and training, advocacy, and lead and train staff on the team. This position provide a critical component of sharing life experiences in support to the client and in partnership with the licensed and license eligible clinicians and paraprofessionals in responding in person referred to AOT assisting persons with connection to the least restrictive community supports and services.
