**Purpose:**

- A. To establish requirements for transporting and non-transporting Advanced Life Support (ALS) unit/engine/squad supply, use, replacement and accountability of controlled substances in Sacramento County.

**Authority:**

- A. California Health and Safety Code, Division 2.5
- B. California Code of Regulations, Title 22, Division 9

**Protocol:**

The policy and procedure for transporting and non-transporting ALS unit/engine/squad supply, use, replacement and accountability of controlled substances is as follows:

- A. Controlled substances **will** be administered in accordance with Sacramento County Emergency Medical Services Agency (SCEMSA) treatment protocols.
- B. All controlled substances will be stored in a secure and accountable manner.
- C. The contents of the storage container will be inspected at every crew change. Both the oncoming paramedic and the off-going paramedic will jointly count, date, time, and sign a Controlled Substance Signature Log. Discrepancies will be reported immediately to service provider supervisor/management. The discrepancy report must be in writing.
- D. In the event that there is not an oncoming paramedic for the ALS unit, **the off-going paramedic and the station officer/company supervisor or designee on duty will perform the counting and signing** ~~will be done by the off. Off going paramedic and the station officer/company supervisor or designee on duty.~~ The station supervisor will accept and retain responsibility for the controlled substance container until a Paramedic arrives to assume responsibility.
- E. All wastage of controlled substances must be witnessed by a second person that documents it in accordance with a provider-developed procedure.
- F. All controlled substances will be re-supplied in accordance with the supply exchange policy developed by the provider.
- G. Paramedic service providers will adhere to all applicable laws and regulations regarding controlled substances (including CCR, Title 22, Div. 9) and ensure that security measures and procedures are followed.

H. Management of opiate patches removed from patients:

- Remove the patch wearing gloves.
- Wipe the residual medication from the patients skin.
- Fold the patch in half so the adhesive side sticks together.
- With a witness present, discard the patch in a biohazard/sharps container.
- Report to receiving facility the removal and waste of the opiate patch.
- Document the removal, waste, and type of the opiate patch, in the ePCR.
