A marijuana prevention campaign was rolled out at the summit, Campaign event days include May 24, 2018 and June 11, 2018. • The Sacramento County Office of Education (SCOE) will be holding a Youth Summit in June 2018. • The County has received a one-time allocation increase of Alcohol and Substance Abuse Prevention (ASAP) funds in the amount of \$3.93 million (\$3.8 million for prevention services and \$130,000 for residential, detox and outpatient services). The goal of ASAP is to help communities develop effective strategies for preventing and managing youth substance use and abuse and subsequent negative consequences. • The Opioid Task Force has been renamed to Sacramento County Opioid Coalition (SCOC). <p>DHS: Sandy Damiano Ms. Damiano attended this afternoon’s meeting. Ms. Damiano is the Interim Director of the Department of Health Services (replacing Sherri Heller).</p> <p>DBHS: Uma k. Zykofsky</p> <ul style="list-style-type: none"> • The formal budget letter from County Executive comes out in a week or two. • Mental Health Services Act homeless plan appears to be approved. • Mental Health is still in the process of negotiating rates for psychiatric hospitals. • The Division is exploring the opportunity to add more mobile teams throughout the County.
