BACKGROUND/CONTEXT:

There have been a number of court cases holding that mandating individuals to 12-Step self-help support groups, i.e. Alcoholics Anonymous/Narcotics Anonymous (AA/NA) is a violation of the establishment clause of the First amendment. The fundamental rule of the Establishment Clause is this: "It is beyond dispute that, at a minimum, the constitution guarantees that government may not coerce anyone to support or participate in religion or its exercise, or otherwise act in a way which establishes a [state] religion or religious faith or tends to do so." Lee v. Weisman, 505 U.S. 577, 587 (1992). In a recent case involving a parolee --Hazle v. Crofoot¹ the U.S. District Court for the Eastern District of California ruled in favor of the plaintiff on his claim that forcing him into a 12-step support group, when he was an atheist, was a violation of the first amendment.

Additionally, the Charitable Choice regulations of the Federal Register 42 CFR Parts 54 and 54a Grants ² apply to the direct provision of substance abuse services. Section 54a.8 states that "If an otherwise eligible program beneficiary or prospective program beneficiary objects to the religious character of a program participant, within a reasonable period of time after the date of such objection, such program beneficiary shall have rights to notice, referral, and alternative services".

DEFINITIONS:

PURPOSE:

To ensure that Substance Use Prevention and Treatment contracted providers are aware of, and compliant with the County's policy of requiring providers to offer non-religious alternatives to 12- Step and other religious-based self-help support groups.

DETAILS:

Whether a provider offers 12-Step self-help support groups e.g. AA/NA on site, or makes referrals to off-site religious-based self-help support groups; the client must be provided with a reasonably accessible, non-religious alternative option or

referral. Examples of non-religious alternative self-help support groups are self-help recovery services such as Smart Recovery, LifeRing, and Life Circle.
