announcements – Paula Lomazzi	Announcements: Paula provided a summary of the tour of tent city in Seattle, Washington that she attended with other advocates and government officials. Many advocates support the concept of having a tent city in Sacramento. Seattle's tent city if funded, in part, by the government with approximately \$120,000 a year to house 100 individuals in a collection of tents and tarps that moves to a new location every 90 days. In Seattle, services are provided on site and community neighbors embrace the concept.
