Public Health Officer's Report	<p>Presented by Dr. Law</p> <ul style="list-style-type: none"> • Sacramento County has seen 2 suspected cases of disseminated gonococcal infection, the State has contacted us to investigate these cases. We have not seen any cases at the Sexual Health Clinic yet. • We have had 3 suspected cases of wound botulism associated with black tar heroin use. • Reports of flu cases have been sporadic most likely due to social distancing and masking right now. • We are in our vaccination phase right now at Cal Expo. All Health Care Providers in Phase 1A can get vaccines, we are monitoring people in the parking lot at this drive through site for 15 minutes. The site is open 9AM-3PM. Other open sites include Safeways, Cal Northstate, Kaiser and UC Davis. CVS and Walgreens are vaccinating at long term care facilities. We are tracking on a database all side effects from the vaccines.
MCAH Update	<p>Presented by Leesa Hooks</p> <ul style="list-style-type: none"> • The Her Health First Services for MCAH clients has expired on 12/31 • Congenital Syphilis is back on the rise and screening guidelines have been expanded so that a 2nd screening test is performed the 1st & 3rd trimester before 36 weeks. It is recommended to have at least 1 lifetime test with all child bearing age women. • MCAH will be participating in a Preconception Health Council of California to bring best practices to our work and start to look upstream. • In the process of developing an equity dashboard that will work with the local hospitals to try and decrease infant and maternal mortality.

Currently 117 clients enrolled with 28 on waitlist. • All of the PHN's have been given the opportunity to receive the vaccine, and some of our nurses have received it so far.
