# 5. 2:50 Medi-Cal Dental Coverage: Crown Lengthening/Crowns

**Cathy Levering** 

Terry Jones presented a concern on behalf of Cathy Levering and member dentists. Cathy reports that SDDS members who are Medi-Cal providers feel semi-precious crowns (preformed, stainless steel crowns) that are reimbursed by Medi-Cal are substandard and therefore they are not willing to place them. Lab-fabricated crowns are the standard of care, but not a Medi-Cal covered benefit. Dentists are not able to choose the material for crowns for their Medi-Cal patients as they are for non-Medi-Cal patients.

A Medi-Cal Dental Provider Bulletin is forthcoming to address the matter. MCDAC can review this policy and possibly appeal to stakeholders to address the issue while keeping in mind that adequate reimbursement of the benefit is critical.

#### **Health Net Dental Plan**

Dorothy Seleski reported that June 22 is the grand opening of the Health Net community resource center at 3725 Marysville Blvd. It will have permanent day staff and include medical and dental navigation services. The site will have a health and job fair on June 22<sup>nd</sup> from 10-2 pm. SDDS will provide an oral health puppet show and Early Smiles Sacramento will provide screenings. The facility offers space to partners to provide health events.

#### **Access Dental Plan**

Martha Cisneros reported that there were 1,500 meals served at the Million Meals kick off in May. The California Department of Education pays for the meals. Early Smiles Sacramento and Access Dental will be at open meal sites to provide services throughout the summer.

# 8. 3:25 California Dental Association Update

Dharia McGrew

Dharia McGrew reported that budget negotiations are ongoing. In May, the governor proposed establishing a 2.5-year sunset on Prop 56 funding. CDA supports long-term continuity for dentists and is against "sunsetting" the funds. An agreement will be made by Monday, June 10, 2019 and the final budget will be signed by June 15<sup>th</sup>.

DHCS received 1,200 applications for the CalHealthCares student loan repayment program and will fund up to 120 applicants this year (both physicians and dentists). The dental portion of the program was launched with \$30 million from last year and will receive an additional \$20 million this year, bringing the total to \$50 million for dental providers.

SB 154 (Pan) – adds silver diamine fluoride (SDF) as a Medi-Cal benefit for specific populations including children 6 years old and under, people with special needs, and adults in skilled nursing facilities. SB 154 passed the Senate and will be heard by the Assembly Health Committee on Tuesday, June 11, 2019.

Western providers will begin VDH in the Sacramento City USD in the fall. The Medical Dental Pilot is working with the local medical society to get more medical providers involvement. The Community Outreach and Parent Education pilot is working to complete the voice-overs for the translated parent education modules.

Mira Yang reported ESS has screened 20,833 children and 16,764 have received fluoride varnish. Statistics reported:
