Subcommittee Topics/Appointments	 Medical Managed Care: Next meeting: Monday July 28th from 3-5 pm Research and Evaluation: No Updates Dental: Currently, there are no hospitals in Sacramento County accepting Medi-Cal enrollees for dental procedures requiring general anesthesia. General anesthesia is used for children who can't sit still, elderly patients with cerebral palsy, seizures, or heart problems, and patients with mental health disorders. If you are a Kaiser Medi-Cal enrollee they will cover general anesthesia. Sutter is temporarily accepting Medi-Cal enrollees, but will soon discontinue all dental. Darrell Steinberg's office is looking into this issue. HIV Health Services Planning Council: Action Item: 5 Appointments to bring to PHAB in August.
Quarterly Chiefs Meeting	 The October 9th Quarterly Chief's meeting has been scheduled for a 3:30-4:00pm meeting time. At the meeting held on June 12th, Executives discussed PHAB's top 4 topics based on the survey results. The Chiefs of Staff expressed support for the Accreditation process.
