#### **Updates/Announcements:**

- TCC Member Gift
  - o TCC members who actively participated and attended at least 2 TCC meetings this past year will be receiving a TCC gift. Those who met the meeting requirement should have received a Doodle Poll allowing them to schedule a pick-up date/time.
- Tobacco Education Program (TEP) Updates
  - o TEP media had to be put on hold for a bit. We anticipate that progress will be made by the next TCC meeting.
  - o TEP's Scope of Work will be receiving a 6-month extension through December 31<sup>st</sup>, 2021. This extension will include 2 new objectives: Communities of Excellence (CX) Needs Assessment and Key Informant Interviews for the End Commercial Tobacco Campaign.

- TCC Subcommittee/Taskforce Updates
  - o Executive Committee
    - The last meeting was on 10/6/20. TEP and the TCC Executive Committee have been working on finalizing the TCC New Member Orientation PowerPoint. It has been approved by the Executive Committee. The next meeting is TBD.
  - o Equity and Diversity
    - The last meeting was on 10/29/20. Members reviewed the TCC New Member Orientation PowerPoint and provided minor edits. The PowerPoint will be given to new members (and other TCC members interested in attending) in the next month. A Doodle Poll will be sent to determine the best date/time.
    - The next meeting will likely be in the 3<sup>rd</sup> or 4<sup>th</sup> week of January, TBD.
  - o Youth and Young Adult
    - The last meeting was on 9/9/20 right after the TCC general meeting. Members continue to share youth-related program updates and resources. Some of the members are assisting TEP with planning activities for the new TCC Speakers' Bureau.
    - The next meeting will be 1/20/21 right after the TCC general meeting (note: date change due to schedule conflict).
  - Cessation Taskforce
    - The last meeting was on 10/8/20. Members continue to share cessation-related program updates and resources. The next meeting will be sometime early next week to focus test 4 draft logos and select a final logo for the TEP quit kits. A Doodle Poll will be sent to determine the best day/time.

#### o Policy Taskforce

- The last meeting was on 11/3/20. Kimberly is stepping down as Policy Taskforce chair. Kimberly has been a TCC member since 1997 and will still be an active member. Keri Hess (Health Education Council) and Marissa Greenband (Breathe California Sacramento Region) will be our new Policy Taskforce co-chairs. Marissa Greenband will be serving on the TCC Executive Committee.
- October 27th Sacramento City Council meeting recap:
  - There is a current 1,000 distance requirement between tobacco retailers which passed in the updated 2019 Tobacco Retail License (TRL) aka flavored tobacco ordinance. Since then, two amendments have been proposed to allow exemptions:
    - o 1) Pipeline amendment- which would allow 7 tobacco retailers who have begun the planning process to be exempted from the proximity requirement.
    - o 2) "Healthy food" amendment- which would allow tobacco retailers who devote less than 5 percent of shelf space to tobacco AND sell certain healthy foods to be exempted from the proximity requirement.
  - Both amendments passed through at the October 27th meeting with a 5/4 vote.
  - Multiple TCC members and youth submitted letters and phone/e-comments speaking against the proposed amendments. Some of the comments and letters were not placed into the record or received by the councilmembers. Marissa has reached out to the city clerk to receive some information on why this happened and to determine ways to avoid this in the future.
  - Jose Mendez (Sacramento City code enforcement) will continue to provide updates as needed.
- SB 793 referendum update- signatures are still being collected by the tobacco industry. The deadline to submit signatures is November 30th.
- The next meeting is TBD.

- o Carol Maytum officially introduced Rachel Alvarez as the Interim Chair of the TCC. Carol will continue to be part of the Executive Committee as immediate past Chair to guide Rachel in this transition. Carol is resigning as Chair of the TCC as she is now working for a Proposition 99/56 funded organization (Action on Smoking and Health). The next Chair and Vice-chair elections will be in November 2021.
